



#### **Eligibility**

- 1. Applied project/research/technology must be within the territorial limits of Hong Kong.
- 2. Eligible projects should be active projects in the stages of corresponding sub-category between 1January 2023 and 30 April 2024 inclusive.
- 3. Shortlisted submission's applicants are **required to attend the final presentation**. Finalist qualification will be seized if applicants are NOT able to join the final presentation.
- 4. Applicants can choose to submit their applications for **any of the categories**, subject to final approval by Organizer.
- 5. The **Organizer** reserves the ultimate right to make final and binding decisions on the eligibility of all applications.
- 6. The decision of the **Judging Panel** shall be final for the award assignments.
